
# **Fund objective**

To provide long-term capital growth by investing in global listed shares in companies that operate in a sustainable and responsible manner. Over the long term the fund aims to outperform the benchmark and provide growth above inflation.

#### **Fund description**

The Fund currently invests in a concentrated portfolio which invests in shares of between 40-60 companies globally where the investment manager believes the businesses are providing solutions to sustainability challenges, falling within four social and five environmental impact themes, such as cleaner energy and sustainable transport. The Fund invests in companies with the dual objective of financial consideration and maximising positive "impact." Impact investing means buying company shares with the intention to generate a meaningful, measurable, beneficial social or environmental impact alongside a positive financial return. The investment manager has discretion over which shares to hold and when to buy/sell them.

#### **Market Commentary**

Equities started the quarter on a weak note as subdued corporate earnings, elevated bond yields and prevailing geopolitical concerns weighed on sentiment. However, markets rebounded sharply after data releases pointed to moderating inflation and resilient economic data, which reinforced the view that central banks have reached the peak of their tightening cycles. Unchanged policy rates in major developed markets and dovish remarks by the US Federal Reserve raised hopes for a soft landing, which further boosted the rally. Against this backdrop, equities in Europe ex-UK and the US gained strongly. Emerging markets also ended higher but underperformed developed markets. At a sector level, optimism around artificial intelligence themes buoyed information technology stocks. Meanwhile, energy stocks fell amid weak crude oil prices. Overall, returns in US Dollar terms were supported by its depreciation against the Euro, Sterling and Yen. Source: Fidelity. This is general market commentary and should not be considered as advice.

Pension Conversion Risk	The price of an annuity changes on a regular basis. This means that the amount of income you can secure with the same amount of money will change. Pension conversion risk is the risk that the amount of income you can buy drops before you retire, because your money is invested differently to annuity funds. That's why, if you wish to buy an annuity to provide a regular income through retirement, putting more of your DC pension pot into bonds to try to match annuity prices as you get closer to retirement age can help protect against this risk. If you wish to continue investing your pension savings during retirement and access drawdown then this is less of a concern.	H
