#### market commentary

US equities ended the year on a strong note with record-breaking advances in major indices, largely driven by a brighter economic outlook as a trade truce between the US and China appeared increasingly likely. More recently, President Donald Trump announced he would sign a phase-one trade deal with China on January 15, effectively compelling both sides to stop adding to the economic damage they have sustained from the imposition of tariffs. Meanwhile, US politics (impeachment) was in the limelight in December, but there has been limited impact to markets at this point, as the vast consensus is that Trump will not be impeached by the Senate. In general, most sectors generated positive returns over the quarter, with sizeable outperformance from information technology and health care stocks. Real estate was the only sector that failed to generate positive returns.
