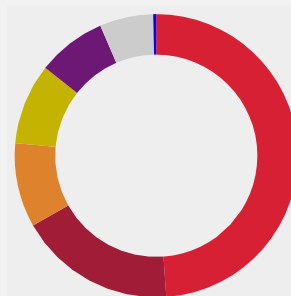

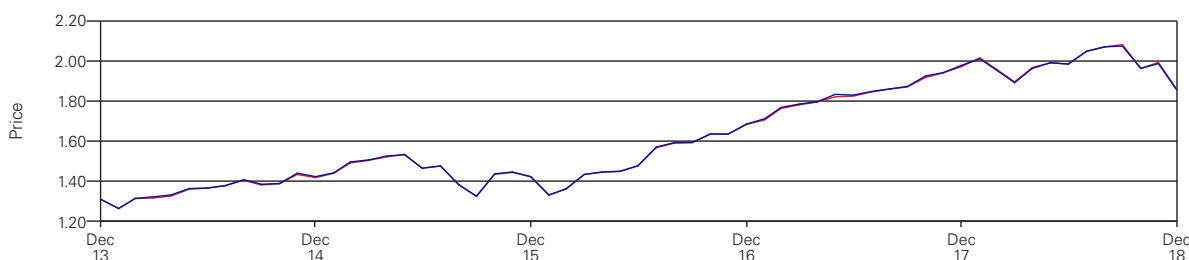

market commentary

Global equity markets fell over the quarter and ended 2018 in negative territory. During the quarter, concerns about the global economy and the interest rate hike by the US Federal Reserve (Fed) weighed on sentiment. Continued Brexit-related uncertainty and US-China trade tensions further concerned investors, despite the US and China reaching a 90-day truce to temporarily halt new tariffs and finalise a trade deal. On the monetary policy front, the US Fed signalled further tightening in 2019, but at a slower pace. It lowered its projections for rate hikes and economic growth in 2019. Against this backdrop, all key markets ended the period lower, with Japanese and US stocks registering a significant decline. Emerging markets also fell, but outperformed developed markets. At a sector level, energy companies declined the most, as crude oil prices fell due to worries about excess supply and weak demand.
