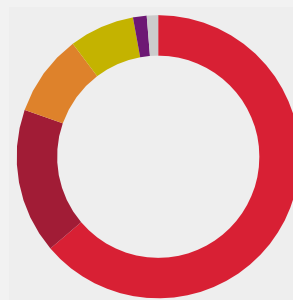

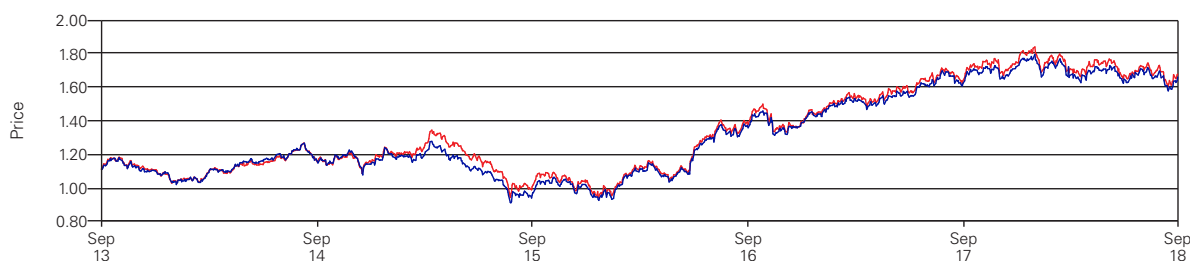

## market commentary

Emerging market equities witnessed a volatile quarter as a strong US dollar; contagion risks from Argentina and Turkey; and geopolitical tensions between the US and Russia weighed on sentiment. The trade rift between the US and China escalated as both countries imposed tariffs and counter-tariffs on exports, resulting in a sell-off across riskier assets. Subsequently, Chinese stocks fell. However, the downside was limited as China said that it would pursue a more 'pro-active' fiscal policy in the form of tax cuts and increased infrastructure spending to boost domestic demand. In Latin America, Brazilian markets endured a volatile period as investors increasingly focused on the Presidential election in October. Meanwhile, the US imposed further sanctions against Russia, with Russian banks bearing the brunt of continued geopolitical tensions.
