

market commentary

Index-linked UK government bonds (Gilts) posted mild positive returns but underperformed nominal Gilts as inflation breakevens (the yield differential between nominal and inflation-linked government bonds of the same maturity) reached the bottom of their trading ranges. Many market participants have started to believe that inflation has peaked. Gilts rallied, despite the Bank of England's (BoE) tightening bias as longer dated Gilt yields remained anchored given stable economic data.
