
## fund objective

# **future**focus

### market commentary

The UK stock market witnessed its first quarterly decline after seven consecutive quarters of positive returns. UK markets also underperformed global markets during the quarter due to a combination of factors. Investor sentiment was weak due to the lacklustre outlook for the UK economy and continued uncertainty around Brexit negotiations. In addition, there was a sell-off in global markets, with investors anticipating faster interest rate increases in 2018, particularly in the US, against an improving macroeconomic backdrop. There were also concerns over a possible trade war between China and the US after US President Donald Trump announced fresh protectionist policies by imposing tariffs on imported steel and aluminium. Overall, large-cap companies underperformed their small-cap peers.
