market commentary

Fixed income markets posted positive returns in the first quarter of 2019. Economic sentiment in the eurozone continued to dwindle, falling to 105.5 points, the worst result in more than two years. In credit markets, both investment grade and high yield credit spreads tightened, retracing a significant portion of widening that occurred in the last quarter of 2018. Furthermore, indications that the trade conflict between the US and China may come to an end also supported risk sentiment.
