

### market commentary

European markets ended a volatile quarter in positive territory. The resurgence in COVID-19 cases in Europe and concerns around a no-deal Brexit unsettled markets. However, positive developments around COVID-19 vaccines/treatments, the European Union's (EU) landmark recovery package and better than expected second quarter earnings led markets higher. The euro strongly appreciated against the US dollar, though some gains were eroded in September due to rising virus cases. Against this backdrop, cyclicals outperformed defensives, with industrials and materials among the biggest gainers. Energy stocks were the worst performers due to the weak outlook for oil demand. From a style perspective, quality and growth stocks outperformed value names, while mid and small-cap companies outperformed their larger peers.
