
## fund objective

#### market commentary

Japanese stocks continued to rise in the third quarter. Share prices fell quite sharply on news of Prime Minister Shinzo Abe's resignation, but made up ground through the remainder of the quarter. At a sector level, communications, materials and industrials were the standout performers. On the other hand, domestic-oriented sectors such as utilities and transportation ended the quarter in negative territory. Financials also declined. In terms of style, small-cap stocks generated the strongest gains, with TSE Mothers, an index of emerging companies, staging a notable rally. Conversely, large-cap value stocks were relative laggards. Macroeconomic indicators recovered through the quarter, as activity gradually regained momentum. Manufacturing output recovered further in August and consumption bounced back after a brief slump in July.
