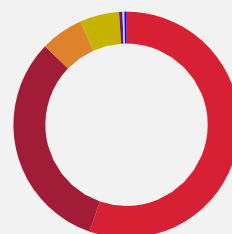

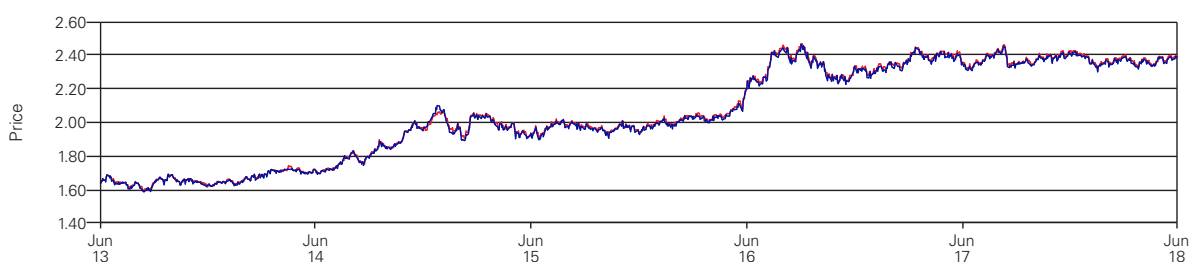

market commentary

Index-linked UK government bonds (Gilts) posted mild negative returns and underperformed nominal Gilts as inflation breakevens (the yield differential between nominal and inflation-linked government bonds of the same maturity) tightened marginally over the quarter. UK inflation expectations were not immune to the volatility that impacted European and global markets. 10-year Gilt yields fell to their lowest levels of the year, before ending the quarter slightly higher as volatility evened out.

Pension conversion risk is the risk that the amount of income you can buy drops before you retire, because your money is invested differently to annuity funds. That's why putting more of your DC pension pot into bonds to try to match annuity prices as you get closer to retirement age can help protect against this risk.	Low
