



market commentary

Index-linked UK government bonds (Gilts) posted positive returns and outperformed nominal Gilts as inflation breakevens (the yield differential between nominal and inflation-linked government bonds of the same maturity) widened marginally over the period. UK inflation breakevens edged slightly higher, driven by a depreciating sterling amid growing concerns of a hard Brexit later in the year, as well as a rise in oil prices. Ten-year Gilt yields also fell amid volatility around Brexit, supported by lower US Treasury yields.
