

#### market commentary

The UK property market was subdued as Brexit-related uncertainties and repressed economic activity weighed on overall sentiment. According to Nationwide Building Society, annual house prices growth in the UK remained below 1% for six months in a row in May. Though the real estate market in the UK is supported by low mortgage rates and positive labour market conditions, ongoing economic uncertainties and challenging conditions over Brexit hampered consumer confidence. However, the number of first-time buyers continued to recover during the quarter, benefiting from weak house price growth and low unemployment rates.
