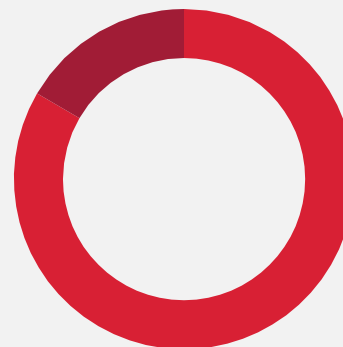

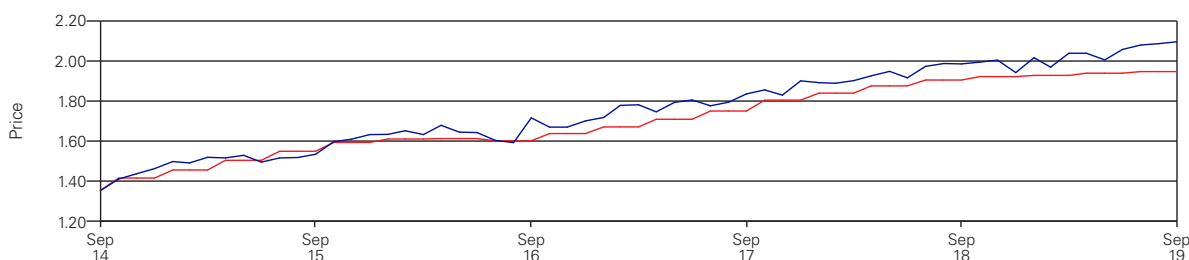

market commentary

UK property stocks grew steadily, albeit at a modest pace. Subdued economic activity and Brexit-related uncertainties weighed on overall sentiment. According to Nationwide Building Society, annual house price growth in the UK remained below 1% for ten months in a row in September. London, where house prices fell by 1.7% annually over the quarter, was the weakest performing region in the country. Though the real estate market in the UK is supported by stable gains in employment and low mortgage rates, ongoing political and economic turmoil hampered consumer confidence.

About the factsheet
