
## fund objective

### market commentary

European markets continued to rally over the fourth quarter. Positive news flow on COVID-19 vaccines, Joe Biden's victory in the US presidential election, the signing of the long-awaited Brexit deal and additional stimulus news were the key positives that drove markets. Though there were some concerns about the new strain of COVID-19 and rising cases across Europe, this was overshadowed by news of the approval and subsequent rollout of multiple vaccines. Investor sentiment was further supported after the European Central Bank (ECB) boosted its asset purchases via the Pandemic Emergency Purchase Programme. Investors were also relieved following the UK's orderly exit from the European Union (EU), after both parties signed a new Trade and Co-operation Agreement to govern their future trading and security relationship.
