



market commentary

Global equities performed positively over the quarter and ended 2019 with strong gains. The accommodative policy stance of major central banks continued to support equities over the period. Investor sentiment improved further in December as the US and China agreed to the phase one trade deal and election results in the UK raised hopes for an orderly Brexit, which has been delayed until 31 January 2020. On the monetary policy front, the US Federal Reserve (Fed) cut interest rates for the third time this year in October. The European Central Bank (ECB) and Bank of Japan (BoJ) said that they would retain key interest rates at current or lower levels to achieve their inflation targets. China also introduced measures to prop up a slowing economy. Against this global backdrop, UK, US and Europe ex UK equities gained significantly. Emerging markets outperformed developed markets, as the US-China trade war de-escalated.
